**CONDITIONS OF PLAY** - The 2009 YONEX/OCBC U.S. Open Grand Prix Championships will be conducted under the conditions as laid down by the Badminton World Federation (BWF) governing BWF Grand Prix Events (in the event of dispute, the decision of the Tournament Referee will be final).

**SCORING** - Men's Singles, Women's Singles, Men's Doubles, Women's Doubles, and Mixed Doubles will use the BWF Rally Point Scoring System.

**ENTRY MAXIMUM** - A maximum number of entrants will be allowed in each event. Qualification matches will be played if required on Monday, July 6. Main draw to start on Tuesday, July 7, with finals on Saturday, July 11.

**CLOTHING** - Competitors are advised that clothing and advertising contained therein must conform to BWF regulations and Grand Prix Events regulations.

**PRACTICE TIMES** - Practice times at the Orange County Badminton Club will be available in the Tournament Registration Package.

**REGISTRATION** - Registration will take place at the Orange County Badminton Club on Sunday, July 5 to Monday, July 6. The Team managers' meeting will be held at the Orange County Badminton Club on Monday, July 6, at 9:00 am.

**TRANSPORTATION** - Airport transportation between the Hilton Suites hotel and the airport will only be provided for players staying at Hilton Suites hotel; all request must reach USAB office by Tuesday, June 9. Venue transportation will be provided only between the Hilton Suites hotel and the Orange County Badminton Club.

**STARTING TIME** - No time cards will be mailed out. The schedule of play will only be given at the team managers' meeting in the Orange County Badminton Club on Monday, July 6, at 9:00 am. All players are responsible to pick up their schedule of play at the Orange County Badminton Club after the team managers' meeting.

**ELIGIBILITY** - Participation in the 2009 YONEX/OCBC U.S. Open Grand Prix Championships is open to members of any national association recognized by the BWF and any currently registered member of the USA Badminton. To enter, national associations should list their players according to national ranking on the entry form. Other contestants must complete the appropriate entry application and forward it, along with the appropriate fees, if applicable.

**FEES** - The entry fees for the 2009 YONEX/OCBC U.S. Open Grand Prix Championships include one admittance and one tournament player pass. Competition will be conducted in men's singles, women's singles, men's doubles, women's doubles and mixed doubles. Entry fee for the first two events is \$100, add \$50 for entering the third event. Checks should be made payable in U.S. funds to USA Badminton.

Competitors entering the tournament as members of their country's national team and officially submitted by their national association will have entry fees waived, provided their entry applications are submitted by the entry deadline. A late fee of \$50.00 will be charged for any entry postmarked after June 9, 2009. USA Badminton reserves the right to refuse entries submitted after the entry deadline.

**PRIZE MONEY** - USA Badminton is able to offer \$80,000 in prize money at the 2009 YONEX/OCBC U.S. Open Grand Prix Championships. This money will be allocated in accordance with BWF rules governing Grand Prix events.

**SHUTTLECOCKS** - The Yonex Aerosena is the official shuttlecock for the 2009 YONEX/OCBC U.S. Open Grand Prix Championships. Practice shuttlecocks will be available at minimal cost from the supplier at the competition venue.

**ACCOMMODATIONS** - Hilton Suites - Anaheim/Orange (400 N. State College Blvd., Orange, CA 92868, telephone: 714-938-1111, fax: 714-704-2323, website: [http://www1.hilton.com/en\\_US/hi/index.do](http://www1.hilton.com/en_US/hi/index.do)) has been selected as the official headquarters and host hotel for the 2009 YONEX/OCBC U.S. Open Grand Prix Championships. Special room rates are \$109 plus tax per room for single/double and \$119 plus tax per room for triple/quad. Room rates include breakfast. Reservations must be made before June 5, 2009 for this special rate.

**DRUG TESTING** - In accordance with the current regulations of both the International and United States Olympic Committee, random drug testing may be carried out at any time during the course of the competition.
