

DEADLINES

All Entry Forms and Fees MUST be sent to your Region Office or Designee by their established deadline, with the exception of those teams who earned a bid for the Open Division at a Bid Tournament. Those teams MUST send their entry form and check DIRECTLY to the USAV Event Department and send copies of their entry form and check to their Region. The remaining forms can be sent with the entry forms, mailed separately to the USAV Events Office, or brought directly to the tournament. It is **STRONGLY** suggested that you send ALL materials by the following deadlines. Please make copies of **ALL** materials sent and bring them with you to the event.

Entry Form and Fee – Open	March 13th East Coast Championships bid earners must have entry & check in by June 3rd .
Entry Form and Fee – Open At-Large	Check with your Region for the Deadline; Regions must have entry form and check in the USAV Events Office no later than June 3rd , 5 P.M. MST.
Entry Form and Fee – Club	Check with your Region for the Deadline; Regions must have entry form and check in the USAV Events Office no later than June 10th , 5 P.M. MST.
On-line Roster Submission – Open	March 12th East Coast Championships bid earners must submit by June 2nd .
On-line Roster Submission – Open At-Large On-line Roster Submission – Club	June 1st June 8th
Chaperone Form	Print, sign, and bring to the event. DO NOT send it to the USAV Event Department.
Proof of Impact certification	June 10 th
Medical Release Forms	June 10 th
1 st On-Line Roster Adjustments without penalty to make the Program Printing deadline	June 10 th at Midnight MST
2 nd On-line Roster Adjustments without penalty (changes will not show in Program)	June 17 th at Midnight MST
Results Reporting – All Divisions	Teams are responsible for submitting their correct 11-digit team code to any event they attend. Results will be obtained from the tournaments rather than each individual team.

SPECIAL DEADLINE NOTES

- **Open At-Large Teams** – Entries **WILL NOT** be accepted after the **June 3rd** deadline.
- **Open Teams** – Bid Tournament winners will be in jeopardy of forfeiting your bid if your entry and check are not received by **March 13th**. If a team earns and accepts a bid at the East Coast Championships, the team **MUST**

register through Advanced Event Systems by **June 2nd**. The Entry Form and check must be sent **DIRECTLY** to and received by the USAV Events Department by **5:00 P.M. MST June 3rd**.

- **Club Teams** – You may request late application for entry. A Club team must meet the following guidelines to apply for consideration after the **June 10th** deadline:
 1. Confirm Region approval
 2. Contact the Events Department to request application.
- Applications **WILL NOT** be accepted if court space and field sizes are filled. There are **NO GUARANTEES** that a team entry will be accepted after the June 10th deadline. **Therefore, enter early!**

USAV REGIONAL VOLLEYBALL ASSOCIATIONS (REGIONS) CANNOT GUARANTEE REGIONAL BERTHS IN ANY DIVISION. ALL ENTRIES MUST BE RECEIVED BY THE USAV EVENT DEPARTMENT AT THE NATIONAL OFFICE PRIOR TO THE DEADLINE FOR A TEAM TO BE ACCEPTED. DO NOT WAIT TO THINK ABOUT ENTERING ON-LINE. TEAM REGISTRATION(S) WILL NOT BE ACCEPTED AFTER THE POSTED DEADLINES. A WAITING LIST MAY BE USED IF THE NEED ARISES TO ROUND OFF POOLS.
