

# 2009 USA BADMINTON Youth Olympic Games (YOG) Trial

The YOG Trial results will determine the junior athletes who will represent the United States in the YOG 2010 Continental Championships Qualification event in Lima, Perú (2/14 – 2/17, 2010).

Please note: There is no USAB funding designated for the YOG Trial or the YOG 2010 Continental Championships Qualification event.

The following criteria will be used in the selection procedure:

1. US Citizens.
2. Born between January 1, 1992 and December 31, 1993.
3. The top 4 boys and top 4 girls will qualify to represent USA. If there are only four (4) or fewer athletes that register for each event (Boy's Singles or Girl's Singles) by October 31, 2009, those athletes automatically qualify to compete at the YOG 2010 Continental Championships Qualification event. No trials will be run for that particular event.
4. Singles events will be Pool Play followed by elimination per USA Badminton regulations. USAB's pool play rules require all of an athlete's pool matches to be completed or none of them count.
5. USAB maintains the final decision regarding player selection in the event of any unforeseen circumstances.

**Entry Deadline:** Postmarked by **October 31, 2009**. LATE ENTRIES WILL NOT BE ACCEPTED.

**Entry Fees:** \$180.00 per person for one single event. This includes an \$80 entry fee and a deposit of \$100.00. If a player is not selected, the \$100 will be refunded. If a player is selected and represents US in the YOG 2010 Continental Championships Qualification event in Lima, Perú, the \$100 will be refunded. If a player is selected, but choose not to play in the YOG 2010 Continental Championships Qualification event, the \$100 will not be refunded. Please make check payable to USA Badminton.

**Please note: If you live outside of CA, your \$80 registration fee is waived.**

**Eligibility:** U.S. citizen born between January 1, 1992 and December 31, 1993. Must have valid USAB membership. Committed to travel & represent the USA in both YOG 2010 Continental Championships Qualification event in Lima, Perú (2/14 – 2/17, 2010) and Youth Olympic Games in Singapore (8/15 – 8/19, 2010). US passport or proof of citizenship is required.

1. I risk bodily injury, including paralysis, dismemberment disability and death, and while particular rules of the sport, equipment, and discipline may reduce this risk, this risk of injury does exist, as well as the risk of damage to or loss of property.
2. I willingly agree to comply with the stated and customary terms and conditions for participation. If, however, I observe any unusual or unnecessary hazard during my presence or participation or if I observe any concern in my readiness for participation, I will immediately bring such to the attention of the nearest official and refrain from participation.

I, for myself, and on behalf of my heirs, assigns, personal representatives and next of kin, hereby release, hold harmless and promise not to sue USA Badminton and its officials, the 2009 USAB YOG Trial committee, Golden Gate Badminton Club, their officers, volunteers, staff, sponsors, sanctioning organizations, and/or agents, ("releasees") with respect to any and all injury and loss arising from my participation, whether caused by the negligence of the releasees, the condition of the premises or otherwise, except that which is the result of gross negligence or wanton misconduct to the fullest extent permitted by law.
