U-22 (Born in 1988 or later), U-19 (Born in 1992 or later), U-17 (Born in 1994 or later)
U-15 (Born in 1996 or later), U-13 (Born in 1998 or later), U-11 (Born in 2000 or later)
U-9 (Born in 2002 or later.) **Maximum of 3 events per athlete, 4th event at official discretions.**
(Athlete's age must be under the age category as of Dec-31-2010).

Entry Deadline: Post marked by **November 19, 2010**. LATE ENTRIES WILL NOT BE ACCEPTED.

Entry Fees: \$55.00 per person for up to three events.
Entry fee waived for U-9, out of state (non-CA) and International (non-USA) athletes.
Please note that online entries at tournamentsoftware.com only for International athletes.

Eligibility: The 2010 USBDF Winter Junior International Championships is open to all domestic and international badminton junior athletes. US athletes must have USAB membership, can be purchased at usabadminton.org or at the tournament.

Awards: Medals or Trophies will be awarded to all winners, runner-ups, semi-finalists, and cons winners.

Conditions:

1. The tournament will be conducted in accordance with applicable BWF and USAB rules.
2. Events may be combined or played round robin format if not enough entries are received.
3. Consolation draws will be held for each applicable event.
4. Up to two Yonex feather shuttlecocks per match will be provided free of charge.
5. All matches will be played in the best 2 of 3 games using the BWF Rally Point Scoring System. Officials could decide that consolation matches be one game only (1x21) due to time constraints.
6. An athlete not ready to play five minutes after his/her match is called will be defaulted.
7. On court warm-ups is restricted to 3 minutes.
8. The 2010 PanAm Junior and US Junior's National results will be used for seeding arrangement. Past USBDF and other PanAm and USAB sanctioned tournaments results may also be used. Adults ranking will not be used for this tournament.
9. Each athlete in a doubles partnership must submit separate entry forms.
10. Entries will not be refunded if cancelled after **November 19, 2010**.
11. The Tournament Director reserves the rights to change any of the above conditions.

2. I willingly agree to comply with the stated and customary terms and conditions for participation. If, however, I observe any unusual or unnecessary hazard during my presence or participation or if I observe any concern in my readiness for participation, I will immediately bring such to the attention of the nearest official and refrain from participation.
